FWCC e-newsletters also featured FCS articles, August 2012 in English written by Louise Salinas (FWCC Associate Secretary) and November 2012 in Spanish written by Luanne and translated by one of the FWCC translators.

Webpage and Facebook

Our Facebook page is popular for conversation. Luanne has prepared a certificate of appreciation for Alex and Dan will take it to him.

Curriculums

US/US Spanish

The translation of our US curriculum into Spanish has been completed and is now available. Translation was done by two FWCC translators and one proof reader. We have certificates of appreciation and gifts (Encourage-MINTS jars) to say "thank you." The Spanish curriculum is to be uploaded to website.

Quaker Faith Journey

A certificate of appreciation has been prepared for Linnette Garcia for inspiring the programme. So far this programme has been shared on the *Quaker* Facebook page resulting in the curriculum being emailed out to Friends in England, Scotland, the Netherlands, Western Australia and South America along with emails to Anne Riggs and Linnette Garcia. *Quaker Faith Journey* needs to be uploaded to website.

UK My Faith and Discovering Faith Badges

Need to continue to work on resources to help Young Friends earn these badges requirements. We also need to work on recruiting UK members.

BSA Religious Relationships Task Force

This year has been more interesting than last year. During the October meeting they talked about Sikh Religious award, with discussion about working on award prior to the award being approved. Jain Religious award was approved; however it still needs fixing to follow age groups.

We need to update memorandum of understanding with Boy Scouts of America. Do we have one? Unclear. If they ask we'll investigate but until then, we'll let it sit.

During the February meeting, the National Key 3 spoke on the membership policy, which currently excludes homosexuals from membership. Originally, an internal discussion regarding the view of major charter organisations, it was leaked to the public. The Baptist resolution is full of assumptions and is Annual Meeting on May 24, 2013 will be the next meeting for discussion of this resolution.

We reviewed the Mission document that BSA wants us to complete. We approved sending BSA the FCS mission statement instead because it is impossible to create a mission document like the sample for Quakers.

We found out we were not on the list for a display for the jamboree. Tom spoke to key staff to get FCS display included. Some religious institutions have rather elaborate handouts to go with their displays. We will erect a peace pole within our display area. People enjoyed our peace testimony.

Duty of God Breakfast - Church of Brethren will be providing invocation. Tom will attend on behalf of Friends.

Friends joyfully thank Tom for his service representing FCS to BSA's national relationships task force.

P.R.A.Y. Report

Luanne provided a report on awards given out over the past three years, 2010-2013. During 2012 - 14 *That of God* awards were awarded to 11 Cub Scouts & 3 Girl Scouts from 10 different meetings in 9 States; 1 *Spirit of Truth* award to a Boy Scout; and 3 *Friends Emblem* recognitions to 3 BSA Scouters from 3 States. Total awards 1989 – 2012: 547 *That of God*; 62 *Spirit of Truth*; and 44 *Friends Emblems* have been awarded.
